Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.heycharlie.org and Hey,Charlie products such as mobile applications and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Hey,Charlie include www.heycharlie.org, "App(s)" and HC. The HC App(s) are a Addiction Prevention tools. By using HC app(s), you consent to the data practices described in this statement.

HC app(s) are designed to aid patients in their decision making. HC App(s) collect, store, analyze and reporting data; these practices are referred to in this Privacy Policy as the "Service".

This Privacy Policy covers how HC, uses and discloses Personally Identifiable Information through the Site and App(s). PII includes information about you that is personally identifying such as your name, email address, and phone number and which is not otherwise publicly available. Your location's legal definition of PII will apply to you under this Privacy Policy.

Hospitals, clinics, practices or other medical groups or healthcare systems that have contracted with HC to permit use of the Service by their respective Clinicians and Patients will be referred to as Medical Partners. Clinicians are practitioners, patient advocates, coaches or other individuals who (as employees of or contractors to a Medical Partner) provide healthcare or related services to Patients; and Patients are individual patients of the Medical Partner who receive medical treatments or other healthcare services from one or more Clinicians, or individuals who are properly authorized representatives of any such patient.

Through their provision of health care services to Patients, Clinicians and Medical Partners will have access to and be responsible for Patient PII and Patient Protected Health Information as defined by Health Insurance Portability and Accountability Act (HIPAA) Privacy Rules or other applicable laws. Clinicians and Medical Partners are responsible for the privacy and security of such information.

Collection of your Personal Information; Consent

In order to better provide you with products and services offered on our Site, HC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Patient Identifying Information (PII)
- Protected Health Information (PHI)

If you purchase HC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

HC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race
- Religion
- Political Affiliation
- Household Income

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through HC's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Sharing Information with Third Parties

HC does not sell, rent or lease its customer lists to third parties.

HC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to HC, and they

are required to maintain the confidentiality of your information. HC will not share any PHI or PII unless permitted by law.

HC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on HC or the site; (b) protect and defend the rights or property of HC; and/or (c) act under exigent circumstances to protect the personal safety of users of HC, or the public.

Your PII/PHI may be shared with your Medical Partner. We may disclose your PII as well as deidentified information to third party vendors who help us operate the Site. These third parties are contractually obligated to maintain the confidentiality of your PII consistent with the terms of this Privacy Policy and to comply with the applicable data protection laws.

Identifiable information about your contacts will never be shared with anyone under any circumstances.

Links to Third-Party Websites

This website contains links to other sites. Please be aware that we are not responsible for the content or privacy practices of such other sites. We encourage our users to be aware when they leave our site and to read the privacy statements of any other site that collects personally identifiable information.

Disconnecting your HC Account from Third Party Websites

You may be able to connect your HC account to third party accounts. Tracking User Behavior; Automatically Collected Information

Information about your device's hardware and software may be automatically collected by HC. This information can include, but is not limited to,: your IP address, browser type, domain names, operating system, access times, referring website/app addresses, etc.. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the HC website.

Security of your Personal Information

HC secures your personal information from unauthorized access, use, or disclosure. HC uses the following methods for this purpose:

- SSL Protocol
- Firewalls and end-to-end encryption protect your PII from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, we cannot guarantee its security. We will retain PII for as long as necessary to provide our services, but no later than 6 years following termination of Services

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Children Under Thirteen

HC does not knowingly collect personally identifiable information from children under the age of thirteen. This service is meant for people over the age of 18.

Your California Privacy Rights; California Do Not Track Disclosures
