PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY

AGREEMENT TO TERMS

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Hey,Charlie (“we,” “us” or “our”), concerning your access to and use of the www.heycharlie.org website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site” or “Service”). You agree that by accessing the Site, you have read, understood, and agree to be bound by all of these Terms and Conditions Use. **IF YOU DO NOT AGREE WITH ALL OF THESE TERMS and CONDITIONS, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.**

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms and Conditions at any time and for any reason. We will alert you about any changes by updating the “Last updated” date of these Terms and Conditions and you waive any right to receive specific notice of each such change. It is your responsibility to periodically review these Terms and Conditions to stay informed of updates. You will be subject to, and will be deemed to have been made aware of and to have accepted, the changes in any revised Terms and Conditions by your continued use of the Site after the date such revised Terms are posted.

The information provided on the Site is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement within such jurisdiction or country. ELIGIBILITY

As used in this Terms of Use: Medical Partners are hospitals, clinics, practices or other medical groups or healthcare systems that have contracted with Hey,Charlie to permit use of the Service by their respective Clinicians and Patients; Clinicians are practitioners, Patient advocates, coaches or other individuals who (as employees of or contractors to a Medical Partner) provide healthcare or related services to Patients; Pharmacy Partners are pharmacies that have contracted with Hey,Charlie to facilitate the use of the Service by their respective Clinicians and Patients; and Patients are individual Patients of the Medical Partner who receive medical treatment or other healthcare services (Healthcare Services) from one or more Clinicians, or individuals who are properly authorized representatives of any such Patient.

MEDICAL DISCLAIMERS

The Service is intended only as a supplement to Healthcare Services, which can be used to assist Patients in their decision-making and Clinicians in communicating best practices during therapy sessions. Hey,Charlie does not provide any stand-alone therapeutic, psychological or medical services to Patients. Hey,Charlie has no direct control over the appropriateness, accuracy, quality, timeliness, scope, price or risks of or associated with any provision of Healthcare Services. Being enrolled in this Service is not a substitute for the care you receive from your Clinician; therefore, you should continue to receive usual care from your Clinician. If you have any questions regarding treatment, medications, or diagnosis, you should contact your Clinician. Your refusal to accept these Terms of Use or to participate in the Service will not affect your ability to obtain services from your Clinician.

The Hey,Charlie Service is not intended for use in any emergency or urgent matter, nor is it monitored by any therapist, licensed medical professional or suicide prevention personnel. **IN THE EVENT OF A MEDICAL EMERGENCY, PLEASE CALL 911 OR THE NATIONAL SUICIDE PREVENTION LIFELINE AT 1-800-273-8255 OR THE NATIONAL POISON CONTROL HOTLINE AT 1-800-222-1222. YOU ACKNOWLEDGE AND AGREE THAT Hey,Charlie IS NOT RESPONSIBLE FOR AND EXPRESSLY DISCLAIMS ALL LIABILITY FOR THE ACTIONS OR INACTIONS OF ANY USER.**

To the extent that any Healthcare Services are offered to any Patient, they are provided by the applicable Medical Partner and its affiliated Clinicians, not Hey,Charlie. Thus, you agree to release Hey,Charlie from any and all claims, demands, damages and liabilities, of any type and nature, known and unknown, suspected and unsuspected, disclosed and undisclosed, arising out of or in any way connected with the provision of Healthcare Services (including any injuries or disability arising therefrom).

The Site, Apps and all other aspects of the Service are provided only (a) in the case of Patients, for your personal, noncommercial use or (b) in the case of Clinicians, for your use related to providing Healthcare Services (within the scope of your duties for the applicable Medical Partner) to Patients (whichever applies, the Authorized Use). However; the the gift card vendor may require the Patient to provide the Patient’s name and contact information such as email. Though unlikely, this may allow the gift card vendor to identify the Patient as a Hey,Charlie user and may identify Patient as having applied to or receiving alcohol, substance use disorder or mental health treatment.

USER REGISTRATION

You may be required to register with the Site. You agree to keep your password confidential and will be

responsible for all use of your account and password. We reserve the right to remove, reclaim, or change a username you select if we determine, in our sole discretion, that such username is inappropriate, obscene, or otherwise objectionable.

PROHIBITED ACTIVITIES
